## CAVE SPRING CITY COUNCIL REGULAR MEETING JANUARY 10, 2017 6:00 P.M.

ATTENDANCE Mayor Dennis Shoaf and Councilmembers Tom Lindsey, Michael Phillips, Nellie

McCain, Charles Jackson, and Mike Ragland were present.

CALL TO ORDER Mayor Shoaf called the meeting to order.

INVOCATION Councilmember Mike Ragland led the invocation.

PLEDGE TO AMERICAN FLAG Councilmember Nellie McCain led the pledge to the American Flag.

**CITIZENS** 

Joyce Perdue Smith, Fairview School, addressed the council stating a wonderful marketing plan is in place for the school. An application for a Certified Local Government Grant of \$22,000 is being prepared to help with the \$42,150 stabilization cost of the school. A match of \$8,000 is required with \$14,000 being funded by Fairview School funds. Ms. Smith requested partnering with Rome, Floyd County, and Cave Spring with each entity donating \$2,666.66. The restoration of the school would stimulate economic growth for the city. The money needs to be in place by the end of the month. Councilmember Lindsey stated the council is meeting with the auditor in the next couple of weeks concerning the city finances. Currently the city is spending a lot of money and he is not sure about participation at this time. There are severe problems with the sewer system that need to be addressed and other pending projects. Currently he does not feel the council is in position to give an answer until after the meeting with the auditor.

Winifred Morrow, AHHAS, stated she supported Fairview School 100%.

Martha Crowe, D.D.A. a member of the special events committee and Bacon-fest coordinator, addressed the council. The D.D.A. sponsored Bacon-fest will be held April 29 at the community center. Contenders pay to put bacon dishes in the competition. On behalf of the D.D.A. she is requesting permission to sell beer and wine at the event. This is a major fundraiser and she is approaching distributors to donate beer and wine. There will be a designated area for consumption and a police officer will be present. She stated it will be a fun, safe, money making event. She will need to have approval by the middle of February.

Wayne Coursey, 15 Alabama Street, stated he is having a right of way problem at Broad Street and River Street. The alley is blocked and property he owns is landlocked. The attorney will research this problem.

Jo Ann Hulsey, 27 Padlock Mountain Road, stated there are potholes in Padlock Road and the sewer cap turns make a loud noise when a vehicle runs over it. The Mayor stated he would look into this situation.

Bernice Howell, 24 River Street, addressed the council on behalf of Jewell Townsend, 19 River Street. She stated when it rains water from the road floods her yard and would like something done about this. The Mayor stated he would look into this situation.
