PRESENT – ALL PRESENT

CALL TO ORDER – MAYOR

DIANE SMITH – WALKABILITY ASSESSMENT – INVITED COUNCIL TO ATTEND WALKABLE COMMUNITIES WORKSHOP WITH DAN BURDEN AUGUST 31 AT FORUM. HE IS NATIONALLY ACCLAIMED EXPERT ON PEDESTRIAN AND BICYCLE INFRASTRUCTURE. SHE ALSO OFFERED TO CITY A ONE HOUR ASSESSMENT BY MR BURDEN OF AN AREA IN CITY. MAYOR APPOINTED NELLIE MCCAIN TO WORK WITH MS. SMITH.

WOMACK ADJUSTMENT REQUEST – COUNCIL DISCUSSED REQUEST. WILL BE ON AGENDA FOR NEXT REGULAR MEETING.

WATER TREATMENT PLANT – JOE HOFER – MR. HOFER UPDATED COUNCIL ON WHAT HAS BEEN DONE AT CAVE AND THINGS THAT NEED TO BE DONE IN FUTURE. HAVE IMPROVED SUPPLY OF WATER OUT OF BACK SPRING BY INSTALLING FLEXIBLE PIPE 8 FEET INTO SPRING. THE FIRST AND IMMEDIATE PROBLEM WHICH NEEDS TO BE ADDRESSED IS CHLORINATION SYSTEM. CURRENT ONE IS OUT OF DATE USING GAS CHLORINE. THIS NEEDS TO BE A CHLORINE SOLUTION SYSTEM AND SHOULD BE ON DISCHARGE SIDE OF PUMP SO CHEMICALS WILL NOT BE FILTERED THROUGH PUMP. THIS PROCEDURE CORRODES IMPELLOR. SECOND – CHECK VALVES IN PUMP HOUSE NEED TO BE REPLACED. WATER MAY BE RECIRCULATING. THIRD – REPAIR SUPPLY LINE FROM FRONT SPRING TO WATER PLANT. THIS NEED TO BE 8, 12, OR POSSIBLY 24 INCH LINE. THESE PROJECTS CAN BE DONE IN 3 PHASES. HAVE CONTACTED CARVER AND CARVER AND ARE NOW WAITING ON PRICES. HAVE IMPROVED SUPPLY OUT OF BACK SPRING BUT NOT PULLING WATER AT FULL PONTENTIAL OUT OF FRONT SPRING. LINES ARE VERY OLD AND NEED TO BE REPLACED. THIS IS PROBABLY REASON PUMPS ARE SUCKING AIR.

SPLOST MEETING – ROME AND FLOYD COUNTY AND CAVE SPRING WILL HOLD A JOINT SESSION ON MONDAY JULY 31 AT FORUM TO OFFICIALLY RECEIVE THE SPLOST COMMITTEE'S RECOMMENDATIONS.

D.O.T. LIST OF ROADS FOR PAVING – MAYOR ASKED COUNCIL TO BEGIN THINKING ABOUT STREETS THAT NEED TO BE PUT ON REQUEST LIST. THIS WILL BE DISCUSSED AND VOTED AT NEXT MEETING.
